

**Unity Agreement and Certification Training Terms of Service  
for the WholyFit Trainer Certification Program**

**AS CONDITION OF ENTERING THE WHOLYFIT TRAINER CERTIFICATION PROGRAM, AND REMAINING CERTIFIED AFTER COMPLETION OF ANY SUCH PROGRAM, I AGREE WITH, AND AGREE TO ABIDE BY, ALL OF THE FOLLOWING:**

**THE WHOLYFIT STATEMENT OF FAITH.** I believe in the divine inspiration and final authority of the Bible as the eternal and living Word of God; in the eternal, omnipotent God revealed in Holy Scripture as Father, Son and Holy Spirit; in the Deity of Jesus Christ, God's only Son, whose virgin birth, physical death and bodily resurrection provide by grace through faith the only means of salvation; and in the transforming presence and power of the Holy Spirit.

**THE WHOLYFIT VALUE OF PROFESSIONAL PEOPLE.** I will fully participate in and do my best to accurately learn the materials provided in WholyFit's certification training program. I will maintain a teachable attitude, be open to correction, and look for opportunities to grow in my WholyFit knowledge and capabilities. To enter the certification training program, I will subscribe to Fitness Pros for Christ at the cost of \$5 per month, and will remain a subscribed member in order to remain certified. I agree to attend a live Gold Certification training within two years of my Silver certification date. I agree to continue my training with continued education through WholyFit, in accordance with industry standard for all professional fitness trainer certifications.

**THE WHOLYFIT VALUE OF PROCLAIMING TRUTH.** I agree not to affiliate with yoga in any way. I will not attend, teach, or sub for any class or training with the name "yoga" in it, including "Christian" yoga, regardless of whether it promotes yoga philosophies. Any participation by me in yoga will immediately cancel my registration in any WholyFit training and void my WholyFit certifications (as applicable), meaning that I may no longer learn, teach, or represent WholyFit in any way, and can no longer use any WholyFit training, materials, routines or other information. When teaching WholyFit and going about my daily life, I agree to avoid yoga philosophies, religions, doctrines, and practices. I will not use or agree with mantras, chakra opening, chanting, transcendental meditation, the "ohm" gesture, music with New Age lyrics or chanting elements, and teachings on Kriyas, reincarnation, Karma, etc. I will not refer to WholyFit as "yoga," nor allow others to do so, in order to avoid sending mixed messages.

**THE WHOLYFIT VALUE OF PROPER PACE.** I agree to maintain the integrity of WholyFit programs. I will use only WholyFit exercises and techniques in my WholyFit classes and trainings. I will not add exercises from other disciplines into my WholyFit classes or trainings, nor will I add WholyFit exercises or techniques into sessions promoted by another fitness name. Once I begin the Silver Certification program, I may practice teaching one-on-one with family and friends, but will not teach WholyFit to the public, whether for pay or for free, until I have received my Silver Certificate. Once I receive my Silver Certification, I will teach only the basic Layer 1 WholyFit; I agree not to teach advanced WholyFit exercises (Layers 2 and 3) until I am Gold Certified or higher.

**THE WHOLYFIT VALUE OF PERSONAL CARE.** I agree to provide personal care to my class participants by praying for them (and with them if they consent); by obtaining health questionnaires and liability releases prior to teaching WholyFit to any person; by modifying exercises as needed to allow persons of all abilities to participate in my classes; and to sincerely look out for "the least of these" to ensure that all feel welcome in my classes.

**THE WHOLYFIT VALUE OF COMMUNITY.** I agree to participate, to the extent I am able to do so, in the WholyFit community by remaining connected to other WholyFit instructors and corporate trainers through Facebook and YouTube; in weekly online prayer; in online continuing education classes for WholyFit instructors; and in live WholyFit events.

**TERMS OF SERVICE FOR WHOLYFIT CERTIFICATION TRAINING.** I understand that WholyFit is a ministry of Fitness Pros for Christ, Inc., which reserves the right to refuse certification and re-certification to any person, whether for violating the Statement of Faith, the WholyFit Unity Agreement, or the Terms of Service, or for any other reason. I agree that no refunds will be issued once I have received access to the training materials, even if I never actually access them, or never complete them. I agree that no refunds will be issued if my training or my certification, or both, are canceled due to my participation or affiliation in any way with yoga. I agree that if I must cancel my attendance at a WholyFit training event, WholyFit will only offer me a credit to attend another event, which credit must be used within 18 months of the original event for which I paid.

I understand that all WholyFit materials and routines are copyrighted, trademarked, and privileged as trade secrets. My acceptance into the program authorizes me to make one digital copy on one device only, and one printed copy, for my own personal use. Other than that, I agree not to duplicate or share these materials in any way, nor to share my program access credentials with anyone. I agree to protect all privileged information received during and after WholyFit certification. I agree not to share or discuss training materials, trade secrets, or WholyFit systems or routines, whether digitally or otherwise, with any person, including other WholyFit trainees or certified instructors who have not yet paid to receive the same materials.

I will receive trademark permission to publicly use and teach only Layer 1 of the GBP system only after receiving my official Silver Certificate. I will receive trademark permission to formally teach and use the multi-layer exercises and techniques (Layers 1, 2, and 3) of the GBP system only after receiving my official Gold Certificate.

Upon beginning certification, I agree that WholyFit may list my name, state and country on [wholyfitclass.com](http://wholyfitclass.com) to help me promote my classes/services.

I understand that online training has inherent risks because the teacher is not present. I assume all risk of personal injury and agree to indemnify and hold harmless Fitness Pros for Christ, Inc., and all its employees, volunteers, successors and assigns from any liability associated with my involvement in WholyFit classes, certification, training and teaching. I confirm that I have no medical conditions that would prevent safe completion of this course, and that my personal medical doctor has authorized me to participate herein.

My registration and payment shall serve as my digital signature agreeing to all the terms herein, which are a binding contract between Fitness Pros for Christ, Inc. and me, governed by the laws of the State of California. Any disagreements at law shall be resolved by binding arbitration in Los Angeles County, California.
